## **Should Where You Live Determine What Assistance You Can Access?**

In this issue of the newsletter, the Foundation has prepared and enclosed a standard letter for use by yourself, your relative, friend or carer.

The letter outlines the inequity of access and affordability for the blind and vision impaired in regards to low vision aids and adaptive technology across all States and Territories in Australia. There are gross inconsistencies between States and Territories.

Our efforts to date to ensure some progress on the matter have been met with a minimal response. It is a difficult area as it covers both State and Federal jurisdictions, and crosses several portfolios. However, the Foundation is confident that with initiative, leadership and a collaborative approach, the issue can be solved.

The Foundation asks if you would consider sending the letter to your local Federal Member of Parliament, as well as any other person you feel may help. You can call the Australian Electoral Commission on
