## **Dear Friends**



Summer is here and the festive season has arrived. Firstly, I do hope that you have a joyous and safe time and one that brings peace and happiness.

At the end of the year it

is a time for reflection and I do look back and think of you - the wonderful people with whom we have had the pleasure of serving in the macular disease community throughout the year. Given that macular degeneration affects older Australians we have the pleasure of meeting, talking with, and serving so many seniors. On behalf of the Board of Directors and the staff let me say it is such an honour and a pleasure to work for you.

We have had a very busy year continuing all of our key programs with the Helpline, publications, education and awareness activities. One of our key areas of work is advocating for your best interests in accessibility and affordability of treatment and rehabilitation. As part of our advocacy work this year we have made 40 submissions to government enquiries and commissions.

There has been one common theme in our submissions - the impact of cost shifting onto older Australians, both pensioners and retired superannuants. We have constantly highlighted how our constituency - those having treatment and those with vision loss

and blindness - are continually under stress as a result. The constant changes to benefits, the decision for over 65s to be excluded from the NDIS and the complexities and costs associated with aged care, are seriously impacting the health and welfare of older Australians.

It is acknowledged that there is an aging population and the demands this brings on the budget. However, the Foundation's position is that this must be balanced with fairness and equity for all, especially those with macular disease. We continue to put the case on your behalf.

This financial year saw the retirement of two board directors our Chair, Elizabeth Carr and ophthalmologist Dr Jim Runciman. Both have given outstanding dedicated service, much valued expertise and steadfast commitment. On behalf of the Foundation we thank them sincerely for their contributions.

The Foundation welcomes Mr Robert Kaye (SC, LLM, LLB, AICD) who was appointed to the Board on 1 July 2016 and appointed Chair 7 September. Robert is a practising barrister (commercial law) and has widespread experience on boards and great passion for our work in macular disease.

## **Research Grants Program 2017**

Macular Disease Foundation Australia is now a leading source of funding for macular degeneration research in Australia. The Foundation's Research Grants Program will open its next round of applications in early 2017, for research commencing in 2018. Grants will be open to researchers based in eligible Australian institutions to pursue research into medical, social, low vision, and nutritional research into macular degeneration.

## **2015 Funded Grants Update**

In October 2015 the Foundation awarded grants to six Australian researchers for projects commencing in 2016. Below is an update on two of the funded projects:



Professor Mark Gillies
Save Sight Institute, The University of Sydney
Grant for \$400,000 over 3 years

Professor Gillies has established a large online database to be used by clinicians in everyday practice to record their outcomes of treatment for wet age-related macular degeneration. The Foundation's funding is to enable ongoing maintenance of this database and the analysis of data, to generate recommendations to maximise treatment outcomes. The research has shown that Australia is now leading the world with regard to treatment protocols and sight saving outcomes for wet age-related macular degeneration.



Dr Gerald Liew Westmead Millennium Institute, The University of Sydney \$100,000 grant over 12 months

This grant is in an exciting new field of research called metabolomics. In this pilot study Dr Liew is now looking at the metabolic waste products in the blood of people with macular degeneration, compared to those without disease. This could potentially result in a practical blood test for early identification of macular degeneration and new targets for treatment.

## Low Vision, Quality of Life and Independence Report

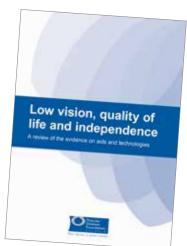
Earlier this year the Foundation commissioned The George Institute for Global Health to conduct a literature review of the current evidence relating to low vision aids and technologies.

As a result the Foundation has now produced a report 'Low Vision, Quality of Life and Independence' which, along with other issues, outlines the impact of low vision; the effectiveness of low vision aids; and examines future technologies. It also includes the cost of vision loss to society; cost-effectiveness of low vision interventions; low vision service access pathways; and the barriers to access low vision services in Australia.

A key recommendation of the report is the establishment of a nationally funded, accessible, affordable and nationally consistent low vision aids and equipment program to ensure that all Australians with low vision can access aids and technologies to maintain independence and quality of life.

The report is being released in the lead up to International Day of Persons with Disabilities

on 3 December 2016, and will be a valuable reference and advocacy tool for the Foundation to be able to continue its efforts on behalf of everyone with vision loss.

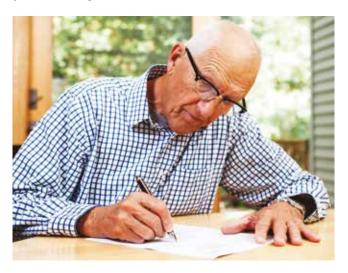
## **Understanding Your Needs**

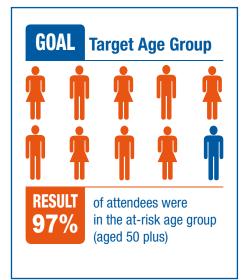

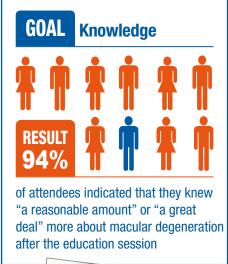
#### **Evaluation of the Foundation's Education Sessions**

# Representation

#### **OCT Medicare Rebate**

From 1 November 2016 Medicare will provide a rebate for the use of an ocular coherence tomography (OCT) scan for the initial diagnosis of wet age-related macular degeneration, diabetic macular oedema and other similar conditions for new patients, when the procedure is performed by an ophthalmologist.

A maximum of one OCT will be funded per year, but only for the initial diagnosis prior to treatment. This means a maximum of two OCT scans will be funded in a person's lifetime - that is - one per eye.

While this new Medicare rebate is good news, the Foundation's position is that OCTs used to monitor ongoing treatment by eye injection should also be covered by Medicare.

The Foundation has been advocating for funding of OCT scans for many years, and will continue to make representations to Medicare and policymakers for a more appropriate rebate.

## **Ozurdex PBS Listing**

The Foundation welcomes the news that Ozurdex® (dexamethasone implant) has now been listed on the Pharmaceutical Benefits Scheme. The listing allows Ozurdex to be used in people with diabetic macular oedema who have already had cataract surgery or are scheduled to have cataract surgery, and have:

- A reaction (contraindication) to a VEGF inhibitor.
- or have failed to respond to a VEGF inhibitor,
- or where a VEGF inhibitor is otherwise unsuitable.

Ozurdex is a steroid that is delivered in a slow release implant placed inside the eye. Based on clinical trial data, the effect of each implant typically lasts between four and six months. Patients with diabetic macular oedema should talk to their ophthalmologist regarding treatment options.

## **Advocacy Update**

Recent representations on your behalf:

- Draft National Aged Care Advocacy Programme (NACAP) Framework consultation: sets the key principles, priorities and outcomes to enable aged care advocacy providers to deliver effective, high quality, and nationally consistent services. NACAP will be aligned with the National Disability Advocacy Programme. The Foundation recommended that 'older people with a disability' be included as a NACAP target group for additional support.
- Productivity Commission Inquiry into Human Services - Identifying sectors for reform: identifying a number of sectors within Human Services which may benefit from increased competition and consumer choice. The Foundation highlighted that greater resources and funding were needed to increase the supply of ophthalmology services in the public hospital system.

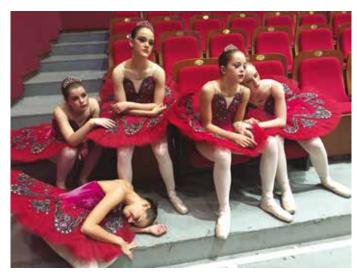

## **Low Vision Aids and Technologies**

'Low vision aids' is the term used to describe the range of devices and technologies that are increasingly being used by people with vision impairment to continue to live independently and perform a wide array of daily living activities. From lights that simulate daylight but stay cool to the touch and new square lenses for magnifying glasses; right through to high-tech electronic magnifying and reading solutions, low vision aids are now an integral part of many people's lives.

While they can be literally life-changing, people on low incomes and pensioners have often missed out on low vision aids because they could not afford them, and there have been very few funding options available. Some changes have occurred of recent times through discussion and advocacy with Government and relevant departments.

These changes enable low vision aids to be now eligible expenditures under two home based aged care programs - the Commonwealth Home Support Program and Home Care Packages.

Under Commonwealth Home Support Program up to \$500 can be spent annually on low vision aids, and this can be increased to \$1000 annually if your home support provider is willing to make a case.

Under Home Care Packages, low vision aids can be included when your package is being designed as part of a range of supports you need, or if there are residual funds left over as your package nears its end.

However, be aware that these benefits are not available from all providers and still offer less support than the NDIS.
